The customer gives permission for delivery personnel to leave beverage products at their home or business in their absence. The customer agrees to protect and hold Paradiso Water Co harmless for, from and against any injury or damage caused by negligence, misconduct, or unforeseen circumstance in the operation and use of the equipment or bottles and releases Paradiso Water Co from any responsibility from consequential, incidental, or special damages of any type resulting from the installation, operation, or maintenance of the equipment and/or consumption for use of any product provided by us in conjunction with this agreement. The customer is fully responsible for regularly cleaning the machines, at a minimum of once monthly, both inside and out. Paradiso Water Co is happy to provide cleaning instructions upon request.
